IronBright offers simplicity, transparency, liquidity and low cost portfolios.

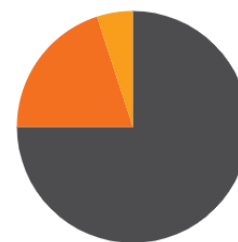
